- A portion of the fire department premises at the Jefferson Township Hall will be made available for winter storage of the vehicle or similar equipment listed above ("the unit"). The unit will be placed and may be moved at Township's sole discretion. The Township may limit the unit owner's access to the premises and restrict activities that can be performed at the storage location.
- Storage will be made available only with a signed agreement and payment of the full storage fee in advance. Fee will not be pro-rated or refunded under any circumstances except as specified in this agreement.
- The unit owner warrants that the unit is their own property or property which they are legally entitled to possess. This agreement cannot be made on behalf of or transferred to another party.

- The unit must be appropriately winterized, and all personal property removed prior to storage.
- The unit owner is solely responsible for insuring the stored property and shall provide proof of insurance to the Township upon request. The unit owner waives any subrogation rights against the Township, its elected and appointed officials, and its employees.
- The use of the premises for storage is solely at the unit owner's risk. The unit owner agrees to release, indemnify, and hold harmless the Township, its elected and appointed officials, and its employees, against any claims, actions, loss, damages, liability, or costs, including reasonable attorney fees, in any way resulting from or related to use of the premises for storage and from any cause, including, but not limited to, casualty, theft, vandalism, weather, temperature, or the acts of omissions of the Township, its elected and appointed officials, and it employees. This provision shall survive expiration and termination of the agreement.
- The unit owner shall reimburse the Township upon demand for all costs incurred but the Township to repair any damage to the premises or other property caused by the unit, the unit owner, or any persons at the premises as unit owner's invitees.
- The Township reserves the right to reject any storage request and may terminate this agreement due to emergency causes beyond its reasonable control. The Township's liability for cancellation is limited to a pro-rated refund for the storage fee.

This is the entire agreement between the parties and may be modified only in a

writing signed by both parties. If any provision in this agreement is found by a court to be unenforceable, it will be ineffective only to the extent of the invalidity.
