July 10, 2023

## **New Business:**

- Truth in Taxation for the 2023 tax year. Hass reported the current millage rates for operating millage as .7798, extra voted operating millage as .2202 to expire 12/31/2029, roads millage as 1 to expire 12/31/2024, and emergency services special assessment at 1.75 mils as presented in the 2023-2024 Revenue and General Fund Budget Resolution, Emergency Services Special Assessment Resolution and the Roads Millage Voted Resolution.
- 2. Board reviewed and discussed proposed Revenue, Expenditures and Salary & Position Schedules. Brunner requested allocating an extra \$10,000 to update our accounting software. We currently have Quickbooks desktop which is no longer supported by Quickbooks. They have moved to an online subscription. Quickbooks is not ideal for fund accounting. Brunner will get estimates of better alternatives to Quickbooks. Bundle and Mendenhall requested an increase in salary for the clerk of \$1000/yr. because of an increase in duties.

  - C. Emergency Services Special Assessment Resolution (2023-11) as presented. Roll call vote: Gillam-yes, Mendenhall-yes, Hass-yes, Brunner-yes, Bundle-yes.
  - D. Roads Millage Voted Resolution (2023-12) as presented. Roll call vote: Gillam-yes, Mendenhall-yes, Hass-yes, Brunner-yes, Bundle-yes.

**Public Comment:** Mr. Adams inquired about the property on M-62 near his property. He noted the pool has been drained and the liner cut to prevent further water accumulation. Hass informed Mr. Adams that the original owner has passed away and his son now own the property.
